#### 'A Conversation with Muslims', Knaphill & Brookwood Church

One of WPOF's central aims is to strengthen relationships between people of all religions and cultures in Woking - to build friendship and understanding between people of different cultures and faiths, for the good of the whole community. WPOF has become skilled at creating 'safe' spaces for people to meet, learn and ask questions of one another.

One such event was a recent 'Conversation With Muslim Women' which WPOF was pleased to facilitate at a women's breakfast hosted by churches in Knaphill and Brookwood. 30 – 40 women gathered over delicious breakfast to meet three brave Muslim women from Woking People of Faith's management committee and trustees. Fatima Martin, Somia Shafiq and Kauser Akhtar introduced themselves and talked briefly about some of the things they most value about their faith, and then made themselves available to respond to a wide range of questions which arose from discussion which took place in groups.



The facilitator, Rev Pippa Ross-McCabe invited attendees to remember that speaking about one's faith to a group of people of a different faith was a brave thing to do – simply because one was subject to the weighty (and incorrect!) assumption that one was speaking for the whole of one's faith group! But the gracious and respectful welcome and interest offered by our hosts suggested that Pippa's caution was unnecessary in this context.

Questions covered a range of topics including issues of culture, understanding of theology, prayer patterns and responses to the tensions

in the immediate national and international context. The integrity, kindness and openness of the panel members was very much appreciated and those who attended commented afterwards that the morning had triggered valuable reflection on issues of prayer, culture and understanding of our Neighbours.

A fortnight later, this same group visited two mosques in Woking where they enjoyed brief tours and time for further questions and exploration. The group was first welcomed at the Shah Jahan Mosque where they were generously hosted by the head Imam and his wife. The group then visited the Al-Asr Education Centre where they were invited to walk around and look and talk to the children in their Saturday School. Their host then tried to answer some of the very hard questions put to her on how Muslims perceived Jesus and did very well! Hosts at both venues were generous with their time. For many who attended this was the first time they had visited a mosque or enjoyed the freedom to ask questions.

There has been very positive feedback from those who attended these events. Woking People of Faith has received comments about how helpful the discussions and visits have been particularly in bringing about a better understanding of Islam - and enabling neighbours better to understand one another.

The format of 'A Conversation With' provides a space for learning and permission for questions (both 'ordinary' and more sensitive) to be asked. It is also a space for listening. Feedback from these events is always very positive – providing ample evidence that people have, often for the first time, met and communicated with a

person from a faith and/or cultural group very different from their own and learned a great deal. Meeting, getting to know as individuals and sharing ideas with people from different backgrounds removes stereotypical perceptions. If you or an organisation you know may benefit from such a conversation, Woking People of Faith would be pleased to discuss possibilities.

Safety, security and living well together: statement by Co-Chairs and Vice-Chairs of the Inter Faith Network for the UK



The recent murders in Paris, as well as reported rises in anti-Semitic and anti-Muslim comments and attacks in the UK and more widely in Europe, have brought in their wake increased anxieties about the safety of Jewish and Muslim communities. In the case of manifestations of violent extremism and terrorism they have brought anxiety about the safety and wellbeing of all communities and of our society overall.

There is, and will be, debate about best ways to respond to these disturbing developments, as well as to the implications of others around the globe. At an immediate practical level, however, where communities feel their very safety is under threat, mutual support is vital. Inter faith initiatives are fundamental to achieving this and play a crucial role

alongside that of the emergency services and other secular agencies working to ensure public safety. The principles, drawn from the IFN and partners document 'Looking After One Another: The Safety and Security of our Faith Communities' remain very relevant. (Download here: http://www.interfaith.org.uk/resources/briefing-notes/doc\_download/130-principles-from-looking-after-one-another)

Among the Government statements made was that of Home Secretary Theresa May: "Without its Jews, Britain would not be Britain, just as without its Muslims, Britain would not be Britain - without its Sikhs, Hindus, Christians and people of other faiths, Britain would not be Britain". We wholly agree. We would add that Britain would also not be Britain without our continuing commitment as people of different faiths, within its four nations, to finding ways to live together well – including with those of non-religious beliefs - and continuing to work together to shape our society in the light of our shared values while retaining the integrity of our religious beliefs and appreciating the positive dimensions of diversity.

There has been fresh discussion in recent times about "values", including in the context of discussion of 'British values'. The Inter Faith Network has, across the years, explored the ideas of 'common values' and 'shared values' in a number of ways, from the seminar The Quest for Common Values http://www.interfaith.org.uk/quest-for-common-values, through working with the faith communities on the Act of Commitment for the new Millennium http://www.interfaith.org.uk/resources/act-of-commitment, to such documents as 'Living Well Together' www.interfaith.org.uk/living-well-together. Further work on values will be taking place within the Inter Faith Network across the year.

## Faith and community organisations sign declaration against hate

Following the Paris attacks, and in commemoration of Holocaust Memorial Day, several faith, community and other organisations have signed a joint statement against hate speech and intolerance.

#### Marriage and Relationships

Guildford & Godalming Interfaith Forum usually devote the first hour of their bi-monthly 'business' meetings to learning more about the beliefs of it's members. Last month they decided to share practices and opinions about 'Marriage and Relationships' in each of the Faiths currently represented, which proved very interesting.

Arranged marriages, Muslim divorce and the notion of Jews marrying their brother's widows were all discussed as well as same-sex marriage which most of the Christian groups are fairly comfortable with. The Unitarian Chapel where the meeting was held was the first Church in Surrey to obtain a license for such marriages but have not been called upon to perform one yet. This would not be possible within the Muslim and Bahá'í communities.

Modern Hindu families were reported to still be opting for arranged marriages, with sometimes one sibling finding a partner through work or studies and then seeking their parent's blessings whilst another will ask their family to introduce a suitable life partner. Bahá'ís must also seek their parents' permission before marrying the person of their choice in order to start out in unity. Bahá'í marriage is for Eternity, not 'Until Death do us part' with partners being responsible for the spiritual development of one another in preparation for the afterlife.

World Interfaith Harmony Week is a UN recognised Week which takes place each year during the first week of February. WIFW was proposed at the UN General Assembly on 2010 by HM King Abdullah II of Jordan and adopted by the UN. It is based on the work of the Common Word initiative which started in 2007 and called for Muslim and Christian leaders to engage in a dialogue based on two common fundamental religious Commandments - Love of God, and Love of the Neighbour - without compromising any of their own religious tenets. ## EHRC to produce new legal guidance on freedom of expression

The Equality and Human Rights Commission has announced that (on 3 February) it will be publishing new legal guidance on freedom of expression. In explaining the context, it says that "Following the recent tragic deaths in Paris, there has been considerable debate both nationally and internationally about free speech. Freedom of expression is a fundamental right which is essential for democracy, a free media and political, artistic and scientific development." The guidance will explain that a) there are legitimate ways the state restrains what can be said but the test for curtailing freedom of expression in law is a stringent one, and much that is offensive is still legal; and b) Freedom of expression can however be restricted in certain circumstances (for example, where it incites violence against others or promotes hatred based on the colour of someone's skin or their sexual orientation or their religion).

# BIG LOTTERY - new funding - Power to Change

The Big Lottery Fund has awarded a £150m endowment to the Power to Change. This is a new independent grant-making foundation that will champion community businesses across England. The Power to Change will be the largest Trust of its kind in Europe and will give funding and support to existing and new community businesses. Examples of support from The Power to Change could be for local people who want to save their local library or leisure centre, run their community shop or pub, or start new enterprises to regenerate a neighbourhood or high street. Full details of the eligibility for the grants is not yet available but it is understood that it will be released later this year.
